The *Government of Romania (GoR)* has received financing from the World Bank toward the cost of the *Romania Secondary Education Project*, and intends to apply part of the proceeds for consulting services.

The consulting services (“the Services”) include: *develop and implement a new website for the use of UMEFP (proiecte.pmu.ro), with functions on information delivery on current projects such as ROSE, communication with the internal server, archive and access of information on current and finalized projects.*

The shortlisting criteria are:

- Demonstrate 10 years of experience in websites and/or e-platforms development;
- Demonstrate experience in minimum 3 projects for educational organisations or institutions/ education-related projects;
- Proven experience of designing websites with a high number of viewers;

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank’s “*Guidelines: Selection and Employment of Consultants under IBRD Loans and IDA Credits and Grants by World Bank Borrowers*” dated *January 2011* (revised *July 2014*) (“Consultant Guidelines”), setting forth the World Bank’s policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture or a sub consultancy to enhance their qualifications.
